MLRC provides free legal representation, including High Court and Tribunal

which raises an important question arising from the Housing (Miscellaneous Provisions) Act 2009. This judgment is particularly significant because it reiterates the law on the exclusive power of the Oireachtas to legislate. In particular, the judgment clarifies the limitations on the power of executive bodies to change or extend the law through regulations which could restrict or alter the rights of applicants. Measuring the extent of homelessness is difficult by its very nature because people who are homeless move frequently. As of 31st March 2011, local authorities have compiled figures showing 98,318 households have a housing need. Rough Sleepers are just a portion of those who are homeless in Dublin and nationwide. CSO Report on Homeless Persons in Ireland

The Central Statistics Office released a special census report on homeless persons in Ireland showing that 3,808 persons were either sleeping rough or in accommodation designated for the homeless on the night of April 10th 2011. Of these 2,539 were male and 1,269 were female. This was the first time that such a “comprehensive approach” in identifying homeless people was undertaken as part of the census and it showed major differences between the homeless and general population in terms of education, health, disability and marital status.
