- Families and homelessness In November, MLRC held a focus group with Dublin 8 and Bluebell CIS to discuss the crisis of families becoming homeless and the possible legal challenges to situations where families are being told by local authorities that there is no emergency accommodation available for them. in the absence of an express right to housing, the State's obligations to provide such emergency accommodation, under current law, is very limited. Local authorities are not obliged to provide housing in individual cases. The possible legal challenges to a failure to provide accommodation centre around the child's right to shelter and Article 8 of the European Convention on Human Rights on the right to privacy and family life.
