## MLRC Policy work

### Right to housing

#### ***Private Members Bill on incorporating Economic, Social and Cultural Rights into the Constitution***

As part of its policy work advocating for a constitutional right to housing, in April, MLRC presented to the Oireachtas Technical Group on the right to housing. This was part of a full presentation, arranged by the ESC Rights Initiative, on the value of incorporating ESC Rights into the Constitution. The Briefing was well received. Following on from it, Thomas Pringle TD launched a Private Members Bill on incorporating ESC rights into the Constitution. Aidan

Lloyd, Chair of the ESC Rights Initiative, Nick Henderson, Economic, Social and Cultural rights Programme coordinator with Amnesty International Ireland and MLRC presented at the briefing in support of the Bill.

### ***Universal Periodic Review***

The UN Universal Periodic Review is taking place in 2016 in relation to Ireland. This is a UN review of countries' records of compliance with all human rights obligations. The Irish Council for Civil Liberties (ICCL) is preparing a comprehensive stakeholder report for submission for this review. MLRC has submitted to this report and is on the steering group for the ICCL report.

MLRC will also be making a direct individual submission, with greater detail, to the Review before the closing date in September 2015. Among the recommendations MLRC will be making are:

- The right to housing should be recognised in Irish law and assimilated into national and local government housing policy.
- The recommendation of the Constitutional Convention to incorporate the protection of ESC rights into the Constitution should be put to the people in a constitutional referendum.
- Equality legislation should be amended to include socio-economic status as a prohibited ground for discrimination.
- The State legal aid scheme should be expanded to include State legal aid in cases involving eviction from social housing.

### **Universal Periodic Review Consultations**

The ICCL and Irish Human Rights and Equality Commission are holding consultations around the country to inform the ICCL stakeholder report to the UN for the Universal Periodic Review. For more information on this work by ICCL and the process, please see:
